Regarding the application for quotation of fully paid shares in Chalice issued pursuant to the Scheme of Arrangement between Sub-Sahara Resources NL and its shareholders ("Scheme") I confirm the following:

- 1. The allotment and issue of 46,706,810 fully paid ordinary shares in relation to the Scheme occurred on 26 August 2009.
- Outside the terms of the Scheme but conditional on the Scheme coming into effect, Chalice Gold Mines has also allotted and issued a further 1,613,727 fully paid ordinary shares to acquire the Sub-Sahara Resources unlisted partly paid shares and unlisted options.
