In December the Company successfully completed an entitlements issue raising \$688,414 before costs.

Subsequently, the Company has entered into a non-binding heads of agreement in relation to acquiring 100% of the issued capital of AusCann Group Holdings Ltd (AusCann).

AusCann was established in 2014 to bring together a leading team of executives focussed upon building an Australian-based, globally connected medicinal cannabis company.

The Company expects to convene a meeting during the next quarter to seek the necessary shareholder approvals to give effect to the proposed acquisition.

The Company ended the quarter with cash reserves of approximately \$751,000.
