Clean TeQ Entitlement Offer and Top-Up Placement Completed

Clean TeQ Holdings Limited (ASX: CLQ) (**Clean TeQ** or **Company**) is pleased to advise that it has now completed the issue and allotment of new shares under its non-renounceable pro rata entitlement offer (**Offer**) which closed on 19 August 2015.
