Proceeds totalling the maximum commitment available (A\$100 million) were received in Q1, 2023. Repayment of the Revised Credit Facility is expected to occur upon receipt of proceeds of the Interim Entitlement Offer, the details of which were announced on 4 April 2023. The Revised Credit Facility is classified as a short-term liability.</p>
