Update on compulsory acquisition of shares in Energy Resources of Australia Ltd (ERA) – List of objectors

On 11 April 2025, North Limited (**North**) lodged a compulsory acquisition notice (**Notice**) in relation to the compulsory acquisition of all the remaining ordinary shares in ERA that it and its subsidiary Peko-Wallsend Pty Ltd did not already own, for \$0.002 per ERA share in accordance with Part 6A.2 of the *Corporations Act 2001* (Cth) (**Corporations Act**).

A copy of the Notice was sent to the remaining shareholders of ERA informing them of their right to object to the compulsory acquisition by completing and returning an objection form by 19 May 2025 (**Objection Period**). The Objection Period has now expired.

ERA shareholders holding at least 10% of the ERA shares covered by the Notice objected to the acquisition before the end of the Objection Period and copies of all objection forms returned to North have been lodged with ASIC.

In accordance with section 664E(3) of the Corporations Act, North has lodged with ASIC and provided to ERA a list of the names of people who hold securities covered by, and have objected to, the Compulsory Acquisition; and details of the securities they hold, being fully paid ordinary shares in ERA. A copy of this notice is enclosed as required by the Corporations Act.

North has applied for court approval of the proposed compulsory acquisition in accordance with section 664F of the Corporations Act.
