

## ASX ANNOUNCEMENT 27 April 2016

### General

Smart Parking Ltd (ASX: SPZ) (**Company**) comprises two main divisions:

- **Managed Services:** Headquartered in the UK, this division specialises in managing car parks on behalf of retail customers, land owners and managing agents;
- **Technology:** Designs, develops and specialises in on-street and off-street leading edge parking technology and software that enables clients to manage parking efficiently and cost effectively.

### Appendix 4C – March 2016

Attached is the Company's Appendix 4C for the quarter ending March 2016.

The Company notes the following:

- Net operating cash inflows for the quarter were \$2.3m. Excluding the movement in client cash, and one off legal costs the net operating cash inflows for the quarter were \$1.2m. This represents a \$1.5m improvement on the prior quarter.
- For convenience, the below table summarises net operating cash flow movements for the Company's financial year to date:

- Cash in any quarter may be impacted by the timing of distributions of client cash. Client funds held by the company increased by \$1.2m to \$5.1m during the quarter.
- The Company's cash on hand (excluding client funds) increased \$0.3m to \$1.9m during the quarter.
- The Management Services Division incurred \$0.5m of capital expenditure during the quarter with its continued strategy of deploying technology solutions on manually operated car parking sites in the UK. Management anticipate that operating cash flow will be positively impacted by this investment in the coming quarters.
