# Tempo awarded more than \$5m in new works

## Highlights

- Tempo Australia has been awarded >\$5m in new works and extensions to existing contracts, including
- New commissioning works at BHP Billiton Iron Ore's Mooka Ore Car Repair Shop, and
- Additional works under its contract at Rio Tinto's Cape Lambert Port B Project
- Tempo also continues to mobilise personnel to site under its contract at the Chevron-operated Gorgon LNG Project and expects to have >175 personnel on site in coming months
- Tempo awarded Rio Tinto 'Make a Difference' award for safety innovations at the Cape Lambert Port B project

Mining and energy sector services company Tempo Australia Limited (Tempo, the Company) (ASX: TPP) is pleased to announce that it has secured in excess of \$5 million in new works.

This award of new works, and extensions and variations to existing contracts, provide further validation of Tempo's ability to execute its business plan of securing targeted new business contracts with tier 1 mining, energy and infrastructure companies and deliver them in a cost effective manner - with a focus on quality and productivity.

### The new works and project extensions include:

- New electrical and mechanical commissioning works at BHP Billiton Iron Ore's Mooka Ore Car Repair Shop, located near Port Headland;
- Extensions and additional works added to its existing contract with Rio Tinto Ltd at its Cape Lambert Port B Expansion Project in the Pilbara region of Western Australia;
- Additional construction works at BHP Billiton Iron Ore's Mooka Ore Car Repair Shop for McConnell Dowell; and
- Additional works at Rio Tinto's Cape Lambert Port Expansion Project on behalf of a leading international equipment supplier.

Tempo's contract with Rio Tinto's Cape Lambert Port Expansion Project was initially awarded in July 2014. It is for structural, mechanical and piping miscellaneous works, and commissioning support. The original contract value was approximately \$13.4 million. Subsequent extensions to Tempo's contract and scope of works have taken the current approved budgeted value to \$34 million.

### **Update on contract at Chevron-operated Gorgon Project**

Tempo is also pleased to provide an update on its sub-contract for the provision of construction, pre-commissioning and commissioning services at the Chevron-operated Gorgon LNG Project on Barrow Island, in Western Australia.

The Company advises that it continues to mobilise personnel to the project site, and expects to have in excess of 175 personnel engaged on site in coming months.

Tempo also continues to build a strong and active tendering pipeline across the mineral resources, energy and infrastructure sectors, and will provide further information on these activities at such time that they become material to the Company.

### **Rio Tinto Safety award**

The Company was recently awarded the Rio Tinto 'Make a Difference' award for safety innovations at the Cape Lambert Port B Project. Tempo identified and implemented a new methodology that reduced the level of manual handling and manning required, as well as reduced costs, in a major conveyor belt replacement program on site. The award is significant recognition of Tempo's commitment to safety and its ability to adopt on-site innovation to reduce the risk of injury.
