Cleansing Notice and ASX Listing Rule 3.10.5A Disclosure

Tempo Australia Limited (ASX:TPP) ("Tempo" or the "Company") provides the following information in relation to the shares issued today (shown in the attached Appendix 3B) pursuant to the Company's placement, announced 20 December 2016, with Angophora Capital Pty Ltd, and in part consideration for the provision of services related to the placement.

Notice pursuant to Section 708A(5)(e) of the Corporations Act 2001

The Corporations Act 2001 ("Act") restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A of the Act. By giving this notice, the Shares noted in the attached Appendix 3B will fall within the exemption in section 708A(5) of the Act.

Pursuant to section 708A(5)(e) of the Corporations Act 2001 (Cth) ("Corporations Act"), the Company gives notice that:

- (a) the Company issued the Shares without disclosure under Part 6D.2 of the Corporations Act; and
- (b) as at the date of this notice, the Company has complied with the provisions of Chapter 2M of the Corporations Act as they apply to the Company; and section 674 of the Corporations Act; and
- (c) as at the date of this notice, there is no information to be disclosed which is excluded information (as defined in section 708A(7) of the Corporations Act) that is reasonable for investors and their professional advisers to expect to find in a disclosure document.



Information required under ASX listing rules 7.1A.4(b) and 3.10.5A

In accordance with ASX Listing Rules 7.1A.4(b) and 3.10.5A, the Company makes the following disclosures:

- (a) The Company today issued a total of 38,956,215 fully paid ordinary shares ("Placement Shares") of which 20,184,836 fully paid ordinary shares were issued under Listing Rule 7.1A and the remaining shares were issued under Listing Rule 7.1. The dilutive effect of the Placement Shares on existing shareholders as a result of the placement is approximately 16.18% of which 7.8% is as a result of the placement shares under ASX Listing Rule 7.1 and 8.38% as a result of the placement under ASX Listing Rule 7.1A. Pre-Placement security holders now hold 83.82% of shares on issue and new security holders now hold 16.18% of shares on issue.
- (b) The Company issued shares as a placement to a single sophisticated investor who had agreed to become a cornerstone investor of the Company, as this was considered an important strategic development for the Company.
- (c) No underwriting agreements were entered into.
- (d) The business incurred fees or costs in connection with the issue of 2% of the funds raised (paid in equity as included in the total shares mentioned above and in the Appendix 3B).
