## **APPENDIX 3B**

As detailed in the Company's ASX announcement of 5 May 2017, AusCann Group Holdings Ltd (ASX:AC8 or 'the Company') notes that the grant of the medicinal cannabis licence by the Office of Drug Control represents the achievement of the performance milestone in respect of 28,230,345 performance shares and 2,794,231 performance rights.

On vesting, each performance share and performance right entitles the holder to be issued one fully paid share in the Company. These shares have now been issued.
