Notice Pursuant to Section 708A(5)(e) of the Corporations Act

AusCann Group Holdings Limited (ASX:AC8) (“the Company”) issued 1,250,000 fully paid ordinary shares on 2 May 2018. These shares were included in an Appendix 3B announcement to the Australian Securities Exchange (“ASX”) released today.
