Standard & Poor's Announces March Quarterly Rebalance of the S&P/ASX Indices

Sydney, Mar. 4, 2011 – S&P Indices, the leading provider of equity indices in Australia, announced today that the following constituent additions and deletions will take place in the S&P/ASX indices, effective after the close of trading on March 18, 2011.

At the March quarterly review the entire S&P/ASX index suite is rebalanced, which includes the All Ordinaries Index. The quarterly rebalance considers the aggregate market capitalisation and liquidity of stocks for the preceding 6-months as a basis for eligibility.

The March quarterly review has resulted in limited turnover for the large cap indices of the S&P/ASX suite with the removal of Westfield Retail Trust from the S&P/ASX 20 the only change. Resources stocks featuring prominently as inclusions in the S&P/ASX 300 representing over 80% of the inclusions.

These changes will be made effective after the close of business on March 18, 2011.
