## **Performance Right Conversion and Cleansing Notice**

Cassini Resources Limited (ASX: CZI) (**Cassini** or **Company**) advises that in accordance with the terms of the Company's performance rights and following Court approval of the schemes of arrangement pursuant to which:

- a) OZ Minerals Limited (ASX: OZL) (**OZ Minerals**) will acquire 100% of the shares in Cassini (**Acquisition Scheme**); and
- b) Caspin Resources Limited (Caspin), a wholly owned subsidiary of Cassini, will be demerged from Cassini by way of a capital reduction which will result in 100% of the shares in Caspin being distributed to Cassini shareholders (**Demerger Scheme**),

2,751,757 performance rights have vested and been converted into fully paid ordinary shares in the Company.

Please refer to the Appendix 2A enclosed for further details in respect of the Shares issued.
