Appendix 3B – Issue and Conversion of Securities

Attached is an Appendix 3B relating to the following issues of new securities in the Company:

- ✓ The conversion of 300,000 unlisted options into quoted ordinary fully paid shares on exercise for cash totalling \$30,000. In addition 300,000 free replacement options with a 40 cent exercise price and an expiry date of 15 January 2008 have been issued.
- ✓ The conversion of 1,869,407 quoted options (ASX Code: RHTOA) into quoted ordinary fully paid shares on exercise for cash totalling \$280,411. In addition 1,869,407 free replacement options with a 40 cent exercise price and an expiry date of 15 January 2008 have been issued.
- ✓ The conversion of 8,000,000 Class D Incentive Shares into quoted ordinary fully paid shares issued in satisfaction of the Class D milestone being the achievement of the Australian Therapeutic Goods Administration (TGA) listing of the FerriScan test. This milestone was achieved in November 2004 with the issue subject to satisfaction of the milestone and a twelve-month escrow that has now expired.
- ✓ The conversion of 3,333,333 Class D Incentive Share Options into unquoted Options with an exercise at 20 cents on or before 06/12/2007 issued in satisfaction of the Class D milestone.
- ✓ The conversion of 3,333,333 Class D Incentive Share Options into unquoted Options with an exercise price of 30 cents on or before 06/12/2007 issued in satisfaction of the Class D milestone.

We are pleased to report that the Company is currently receiving a number of RHTOA Option Exercise Forms and we expect to lodge further Appendix 3B's to cover these option conversions over the next few weeks.

Option holders holding RHTOA options may elect to convert their 15 cent RHTOA options into ordinary shares prior to 8 December 2004. By doing so, the Option Holder will receive one ordinary fully paid share and one free replacement option with a 40 cent exercise price and an expiry date of 15 January 2008. This option trades under the ASX code RHTOB.
