
National Nominees Limited (NNL) and various other custodians hold shares in the Company as custodian and for which Ausbil is either:

Each investor in a fund owns an individual interest in the Fund's assets; no investor directly owns any asset of the Fund. The unit holding of each Fund varies from time to time as clients enter and withdraw from the Funds.
