



## ISSUE AND ALLOTMENT OF SHARES - CLEANSING STATEMENT

The Directors of Red River Resources Limited (ASX: RVR) (**Company**) announce that they have issued and allotted 1,535,502 Ordinary Shares from the Vesting and Exercise of Performance Rights by the directors and an employee from the 2018 Grant pursuant to the terms and conditions of the Performance Rights Plan Rules.

Of the remaining performance rights from the 2018 grant, 954,500 have lapsed and 66,667 were forfeited.

In addition, 800,000 Options with a 30 June 2022 expiry, 138,998 2019 Performance Rights and 127,446 2020 Performance Rights have been forfeited.
