



## RVR enters new copper concentrate offtake agreement with Glencore

### Highlights

- Red River signs new offtake agreement with Glencore for 100% of copper concentrate produced at Thalanga until June 2023
- Agreement continues the relationship established with Glencore in 2017

Red River Resources Limited (“Red River” or “the Company”) (ASX: RVR) is pleased to announce it has signed an offtake agreement with leading global commodity producer and marketer Glencore International AG (“Glencore”) for copper concentrate produced at Red River’s Thalanga Operations in northern Queensland. The offtake agreement covers 100% of the copper concentrate produced at Thalanga until June 2023. Under the terms of the offtake agreement Glencore will take delivery of copper concentrate at the Thalanga mine gate.

Red River Managing Director Mel Palancian said, “We are pleased to have a new agreement with Glencore for copper concentrate produced at Thalanga. We have had great relationship since 2017 and we look forward to continuing this.”
