

ADDENDUM TO NOTICE OF ANNUAL GENERAL MEETING

Tempo Australia Limited (ACN 000 689 725) (**Company**), hereby gives notice to shareholders of the Company that, in relation to the Notice of Annual General Meeting dated 27 April 2018 (**Notice of Meeting**) in respect of an Annual General Meeting of shareholders to be held at 10.00am (WST) on 31 May 2018 at the InterContinental Perth City Centre, Gallery Suite 3, Level 1, 815 Hay Street, Perth, Western Australia (**Meeting**), the Directors have determined to add a new Resolution 5 as set out below and to supplement the information contained in the Explanatory Statement provided to Shareholders in relation to the matters set out in this Addendum to the Notice of Meeting.

Definitions in the Notice of Meeting have the same meaning in this Addendum to the Notice of Meeting unless otherwise updated in this Addendum to the Notice of Meeting.

Shareholders who wish to vote by proxy can complete the Proxy Form enclosed and return it to the Company by following the instructions on the Proxy Form. All details regarding voting at the Annual General Meeting are set out in the Notice of Meeting.

An additional Resolution is inserted as follows:

6. RESOLUTION 5 – APPOINTMENT OF AUDITOR

To consider and, if thought fit, to pass, with or without amendment, the following resolution as an **ordinary resolution**:

"That, for the purposes of section 327B of the Corporations Act and for all other purposes, Ernst & Young, having been nominated by a Shareholder and having consented in writing to act in the capacity of auditor, be appointed as auditor of the Company with effect from the close of the meeting."

EXPLANATORY STATEMENT

Section 6 of the Explanatory Statement is added to the Explanatory Statement.

6. RESOLUTION 5 – APPOINTMENT OF AUDITOR**6.1 General**

On 24 July 2017, the Company announced to ASX that it had appointed Ernst & Young as its auditor to fill the casual vacancy left by RSM stepping down as auditor, following receipt of consent from ASIC to do so.

Under Section 327B, the appointment of Ernst & Young to fill that casual vacancy lasts until the Company's next Annual General Meeting.

Accordingly, having received a nomination from a shareholder, the Company now seeks approval from Shareholders to the formal appointment of Ernst & Young as the auditor of the Company.

Ernst & Young has given its written consent to act as the Company's auditor subject to shareholder approval of this resolution.

- (b) return both forms together.
