#### **Notice of Meeting**

The Notice of Meeting, accompanying explanatory statement, and annexures (together the **Meeting Materials**) will be made available to shareholders electronically unless shareholders request to receive a hard copy. The Meeting Materials will be released to the Australian Securities Exchange and distributed to shareholders on or before Monday, 10 October 2022.

Recent legislative changes to the Corporations Act 2001 (Cth) mean there are new options available to shareholders as to how you receive communications from the Company. E&P encourages all shareholders to provide an email address so we can communicate with you electronically when shareholder notices become available online, for items such as meeting documents and annual reports.

Shareholders can still elect to receive some or all of their communications in physical or electronic form, or elect not to receive certain documents at all, such as annual reports.
