Clean TeQ Aromatrix awarded \$1.6M in odour control contracts in Victoria, Queensland and Tasmania

Clean TeQ Holdings Ltd's (ASX: CLQ) 59% owned air purification subsidiary Clean TeQ Aromatrix Pty Ltd ('CTX') has been awarded three significant odour control projects, valued in total at \$1.6M.

Including these new projects, CTX currently has contracted work in hand totalling approximately \$4.7 million in revenue expected to be delivered over the remainder of the 2015 and 2016 financial years. CTX is also continuing to bid on a number of further trading and tender opportunities which are expected to lead to significant additional future revenue growth.

The contracts will see the installation of three air treatment facilities using CTX's proprietary OdourTeQ™ BioTrickling Filter and CleanCarb™ Activated Carbon Filter technologies.

In Victoria, Barwon Water (contracting via Fulton Hogan Construction Pty Ltd) has selected CTX for the provision of an air treatment facility to ventilate their largest trunk sewer which transports effluent from Geelong to their Blackrock water reclamation plant. The facility has been designed to ventilate the sewer and will address odour and corrosion issues associated with the transportation of wastewater.

Redland City Council in Queensland has contracted CTX to provide an air treatment facility to ventilate and treat odours generated by the inlet works to their Wastewater Treatment Plant located in Cleveland, South East Queensland. This installation will utilise the OdourTeQ® platform to eliminate odours with a small CleanCarb™ polishing filter designed to ensure a 'Zero Odour' outcome.

CTX has also been appointed to provide dispersion modelling and detailed design as a precursor to the construction of an air treatment facility for TasWater (contracting via Waternish Pty Ltd). This system will address odour and corrosion on one of TasWater's many pump stations that form part of the network that transports effluent from domestic users to a wastewater treatment facility.

Mr Matthew Lakey, Managing Director of CTX, commented:

"The award of these significant contracts is a positive demonstration of CTX's leadership in the biological odour control market. We have now signed up a significant project pipeline and look forward to continuing to grow the business in the coming months".
