

# ASX ANNOUNCEMENT 9 JUNE 2021 MAY BITCOIN AND DIGITAL ASSET EXPOSURE

DigitalX Limited (the **Company**), the first ASX-listed Bitcoin-related company, provides the following monthly update to shareholders on its funds under management and value of Bitcoin related assets as at the **end of May 2021**.

The Company notes inflows of \$0.65m (inclusive of DigitalX's additional investment of \$0.4m). Noting the recent period of significant volatility, the Company is pleased to see continued net inflows into the Bitcoin and digital asset funds.
