As announced to ASX on 14 July 2021 Norwest has commenced an Entitlement Offer on a 2 New Shares at \$0.07 for every 3 shares held basis to raise up to \$5.2m (Entitlement Offer). In particular:

- The Entitlement Offer is partly underwritten to \$1.5m, and Norwest has received the full underwriting commitment;
- Major shareholders have given written commitments to take up their entitlements to the amount of approximately \$1.1m;
- There is a facility for shareholders other than related parties to subscribe for New Shares above entitlement;
- Euroz Hartleys has been appointed Lead Manager to the Entitlement Offer.

Norwest will therefore raise at least \$2.6m under the Entitlement Offer and expects to raise significantly more than this.
