Resonance Health Ltd (ASX:RHT) Appendix 4C – 1st Quarter Cash Flow Report

Resonance Health Limited today released its first quarter Cash Flow Report for the period ending 30 September 2012.

Cash at 30 September 2012 was \$1,214,566 representing an increase of \$34k for the September quarter. This compares to a net cash outflow of \$42k in the previous quarter. The Company continues to have no debt.

Receipts from customers were up 90% on the prior quarter due to the reduction in trade receivables in July 2012 and the prepayment of some FerriScan[®] services to be provided over the coming year.

During the quarter the Company announced that it has been contracted to provide FerriScan[®] services in two new clinical trials and the FDA has requested a broader Indication for Use for FerriScan[®] to support its role in the treatment of patients with iron chelation therapy.
