The drawn amount at the end of the quarter was EUR 0.258 million. • In June 2020, SomnoMed Germany GmbH (Germany) secured a EUR 0.5 million (A\$0.802 million) Government-backed unsecured loan facility with Commerzbank (maturity of up to 6 years). The interest payable is 3% per annum. This loan expires on 30 June 2030. The drawn amount at the end of the quarter was EUR 0.344 million.
